How to Claim your \$100 **First-Time Member Voucher**

Background

LGAA's Membership Policy sets out that any new applicant for membership who is employed with a municipal government and has never been a member of LGAA is eligible for a First-Time Member promotional discount.

Eligible First-Time Members will receive a 50% discount on their first-year membership fee, plus a \$100 credit voucher that may be used to:

- Offset the cost of any event or program hosted by LGAA, or
- Offset the cost of their membership fee in the second year of membership*.

This guide provides instruction on how First-Time Members can claim the \$100 credit voucher.
